Winter (#3 Issue) January 1, digital

Spring (#4 Issue) March 1, digital

Late Spring (#5 Issue) May 1, digital

Summer (#1 Issue) July 1 (paper)

Fall (#2 Issue) October 1, digital

- Advertisers must agree to the following terms, sign, and send this contract to the **VAST Treasurer** as soon as possible.

- 1) Advertiser agrees to protect and save harmless Virginia Association of Science Teachers, Inc. (VAST) from any suits for the violation of right to privacy, plagiarism, copyright infringement, and any and all claims in connection with the advertisements referred to in this contract and assumes liability for all the content of advertisements printed and for any claim arising from there made against VAST.

- 3) Send advertisements to the editor by: **July 10 (summer)** for inclusion in **Newsletter Issue #1** (4200 copies sent past year) This issue is mailed to members by USPO and to all VA public schools, many private schools, and to Va superintendents.
- 4) Executed contracts should be received by the treasurer prior to the editor's issue due dates indicated above. Enclosing payment with contract reduces organizational costs. To be billed, please indicate below, and an invoice will be mailed upon receipt of contract. All invoices are due upon receipt. Any balance due after 30 days is subject to 1.5% interest per month (18% yearly).
- 5) The right to decline any advertisement VAST deems to be inappropriate or contrary to the mission of VAST.
- 6) Discounts do not combine and the highest discount will be honored.
